

Description of Monument

The monument comprises a settlement of post-medieval date, situated on the northern slopes of Meall Meadhonach in a clear area within a forestry plantation.

The monument consists of a number of structures. These include 5 rectangular houses, 6 small oval shielings and 8 other irregular foundations, possibly shielings. There is also a stone-built sheepfold 14m in diameter to the S of the site. The buildings vary in size from about 3m across to some 15m by 3.5m. The walls of the structures are all vegetation-covered and measure up to 0.4m wide and up to 0.3m high. The two most southerly structures lie E-W whilst the structures to the N of the forest road lie roughly N-S.

The scheduled area measures a maximum of 300m N-S by 240m E-W, to include the buildings and an area around them in which traces of activities associated with their construction and use will survive as shown on the scheduling certificate (Appendix 1).

Forest Enterprise's Objectives

- i. To ensure that the monument and its surrounding area are kept free of trees and scrub, thereby preserving both the archaeological remains and their setting.
- ii. To maintain and improve access to the monument, and to enhance its setting in the wider landscape.

Management

Issues requiring attention:

The monument is situated in a large clearing of coniferous trees, which were planted in 1984 and 1985, and is bisected by the forest road. Approximately one third of the site lies to the south, and two thirds to the north, of the forest road. The trees currently define the outer edge of the scheduled area (see appendix 5). In most cases, the trees are well over 20m from any of the structures, but some trees require removing on the northern edge of the site where two structures are within 10m of the plantation, and at the south-east corner where there is a structure within 10m of the trees. There is a spruce tree on the side of the road in the middle of the site which requires removing. The site requires waymarking from the forest road. The structures on the monument are mainly grass covered with small patches of heather and rushes. There is some sign of woody regeneration/colonisation within the scheduled area in the form of scrubby willow. This appears not to be increasing and no action is deemed necessary in this respect, apart from monitoring any spread.

Work proposals

a <u>Harvesting operations</u>

No harvesting operations are planned during the term of this management plan, but the trees which are closer than 20m to structures within the scheduled area will be removed. If any new woody regeneration/colonisation is found within the scheduled area during routine inspections, then the following conditions will be applied:-

All trees and shrubs shall be cut off at ground level, the stumps or roots being left in the ground and not grubbed out. Trees should be cut by hand or by the use of a hand held power saw. These measures will enable the trees to be felled in such a way as to cause no damage to the remains of the monument or the ground surface within the scheduled area.

Where necessary stumps should be treated with the appropriate chemical according to the statutory "Code of practice for safe use of pesticides on farms and holdings" (HMSO 1990) prepared by MAFF, HSC and DoE.

Any brash resulting from these operations shall be removed well away from the area of the scheduled ancient monument. Cut timber shall be removed from the site by cutting into easily transportable pieces, rather then by dragging, to prevent damage to underlying archaeology. If brash is to be burned, this operation shall be carried out well away from the scheduled area.

If appropriate, a harvester may be used to fell and lift trees from the scheduled area that are within its reach as the machine itself must be placed in a position out with the scheduled area. Care must be taken not to disturb the ground surface within the scheduled area during these operations.

No vehicles shall enter the scheduled area.

b Site clearance

The scheduled area, and an area 20m beyond the edge of the scheduled area, will be kept tree free. Any natural regeneration of trees, scrub, or bracken will be assessed at yearly Intervals and controlled using hand held scrub cutters and herbicides where appropriate. No vehicles will be allowed in the scheduled area.

c Public access

Access is via the A836 Lairg to Altnaharra road, turning on to the gravel road signposted to Dalnessie at grid reference NC576139, then by taking the second forest road on the right at grid reference NC621143 and following this road to the site.

Public access will be improved by provision of waymarking and maintenance of a clear track to the site.(Appendix 3)

This route and way marking will be inspected on a yearly basis in September each year.

d On site access

Good site access will be maintained by the removal of any scrub from the site on a regular basis. The condition of on site access routes will be checked on a yearly basis, in September.

e <u>Interpretation</u>

It is not intended to provide Interpretation panels at this site, but a small map and information leaflet is to be produced which details the SAMs on Forest Enterprise land. Details of sites in the local area will be available from the Forest Enterprise Dornoch District office on request.

Interpretation panels, information boards and way markers, when provided will be erected out with the scheduled area.

f Tree planting

No tree planting will take place within the scheduled area or within 20m of the edge of the scheduled area.

g Site maintenance

The site is to be checked on a yearly basis to identify any site maintenance required. No work other then those specified in the management agreement conditions of this plan, shall be carried out in the scheduled area without the prior approval of Historic Scotland.

h Access/signs maintenance

Access paths and way markers will be inspected on an annual basis, and any maintenance required shall be recorded and carried out.

Management Agreement Conditions

The Occupier undertakes:

- 1. To monitor and control all scrub, tree and bracken regeneration in the Scheduled Area to prevent colonisation.
- 2. Not to plant trees within 20 metres of the Scheduled Area.
- 3. Not to cut any drains, ditches or dykes across, or within 20 metres of, the Scheduled Area.
- 4. Not to use the Scheduled Area as a dump for any material.
- 5. Not to use wheeled or tracked vehicles within the Scheduled Area.
- 6. Not to park any farm or forestry machinery on the Scheduled Area, nor to use the area for storing any materials.
- 7. Not to construct any building works or access tracks within 10 metres of the Scheduled Area.
- 8. Not to afford any person access to the Scheduled Area for the purpose of using a metal detector unless that person can produce the written consent of the Secretary of State.
- 9. To permit any authorised representative of the Secretary of State access to the Scheduled Area without prior notice.
- 10. To allow public access at all reasonable times to the Scheduled Area. An access route will be way-marked as shown on the attached map extract (Appendix 3). This route will be checked annually to ensure it provides adequate guidance and access.
- 11. To report any objects such as pottery, flint or bone, or archaeological features, which are found within the Scheduled Area. Such objects should be left undisturbed and reported to the Council Archaeologist, Historic Scotland or your local museum.

Liaison

Formal consultation every 5 years with Historic Scotland to review the management strategy of the monument prior to the preparation of the subsequent Management Plan. Meetings with local Historic Scotland staff as required.

Monitoring

Monitoring of the site will be carried out on a yearly basis in September each year as described in work proposals (g)



Lairg Parish







Description and assessment of management requirements

e site lies on the lower N slope of Meall Meadhonach. The monument, a settlement and shielings, is a scheduled area split E-W by the forestry road and N-S by Allt a' Mhadaidh-Ruaidh. The site is a clear area within the forestry plantation the edges of which define the scheduled area. The site is grass and heather covered with the main structures on the grassy areas. There are 2 sub-rectangular structures on the SE side of the forestry road and 16 on the N side. The size varies form c.4m by c2m up to c.19m by c.4m. There are indications of field boundaries. and cultivation patches. There is a ruined sheep fold c.14m in diameter at the NE end of the area, this is the only structure with any quantity of visible stone. The majority of other structures are identified by the wall remains creating a mound in the grass and have no visible stone. There is no indication of a head or ring dyke around the settlement. The site is in a stable condition with a little grazing by deer. There is no sign of regeneration but there is one conifer tree beside the road which ideally would be removed. There is some scrubby willow on the site but it is not increasing and if not causing a problem at present. The site will be subject to a Forest Enterprise Management Plan.

aated on the northern slopes of Meall Meadhonach thisgrass and heather covered site, surrounded by coniferplantation, contains several sub-rectangular structures, someof which have internal divisions and the remains of asheepfold.

The sub-rectangular structures vary in size from 6m x 3mto 11m x 3m with "walls" up to 0.4m wide x up to 0.3m high.All are vegetation covered. The two most southerly stuctureslie E-W whilst thwe structures to the N of the forest roadlie roughly N-S.

The sheepfold has a diameter of 8m and walls 0.5m wide xup to 0.4m high. There is a considerable amount of stonescattered in and around the fold.

The vegetation on the site is in general up to 0.4m high, though around the perimeter where willow herb is abundant itis much higher, and causes problems as regards structurerecognition/visibility.

The surrounding land is covered by ploughed coniferplantation.

I could find little evidence of damage on this site, other than a number of dead trees scattered by the side of the forest road that crosses the site, though there has been arecent report to that effect.





The proposal arose from programme B1 Forestry

The area was excluded from Forestry Commission planting and is being scheduled to regularise the protection of the monument.

The monument is a Post Medieval settlement which consists of a range of structures. These include 5 rectangular houses, 6 small oval shielings and 8 other irregular foundations, possibly shielings. The buildings vary in size from 3m across to 15m by 3.5m and survive in a variety of conditions which may indicate a fairly long period of occupation. There is also a stone-built sheepfold 14m in diameter to the S of the site. This settlement would appear to represent part of a 'cottar town', many of which were destroyed during the clearances of the late eighteenth and early nineteenth centuries.

The area to be scheduled measures a maximum of 300m N-S and 240m E-W, to include the buildings and an area around them in which traces of activities associated with their use will survive, as shown in red on the attached plan. A recent forestry track and adjacent tipping is excluded from the area to be scheduled.

The monument is of national importance as a Post Medieval settlement which has the potential to enhance considerably our understanding of the domestic organization and farming practices of its inhabitants. The site is also of importance from the perspective of the process of Clearance in this area of the Highlands and is one of an important group of deserted Post Medieval settlements to the north of Lairg.
