"Lethbridge is of the opinion that those boat-shaped burials on Sanday are unconvincing, and Rivet considers them to be more probably kelp-drying Kilns".

"Situated at NG 2875 0391 is a structure similar to the other "Viking Burials" on Canna and Sanday, (see also NG 20 NW 3). It measures 7.5m NW-SE by 1.5m and appears to be open at both ends.
