"I have never been able to find any flint implements in the heap. but in the arable field immediately above the site numerous chips of flint have been found, many of them now in my possession, but on a few only are there any signs of secondary markings It would seem that the place was the habitation of a race of people who had established a flint factory there the manufacture of arrow heads, spear heads, scrapers, and so forth, and the unworked chips now found are the debris of the factory "
