We have been appointed by the Congregational Board for Fearn Abbey and Nigg Chapelhill Parish Church on repairs to the fabric of the Abbey Church which are likely to be supported by grant assistance from Historic Scotland. A report by Historic Scotland District Architect has been prepared.

One of the matters which will prove difficult to reconcile is the question of rainwater disposal due to the burial lairs which appear so close to the foundations of the building, and which will make an exercise to introduce sub-soil drains and soakaways a delicate, and potentially costly exercise. The matter had not been resolved during the last phase of repairs, in that the downpipes are not connected to sub-soil drains and simply discharge large quantities of rainwater over the ground in concentrated areas, which is having a damaging effect on the fabric of the church.

We reported at a recent meeting of the Congregational Board the need to engage the services of an archaeologist in this particular exercise, and the suggestion was made that in the first instance we should contact your own department. We would be grateful to hear whether you would be in a position to offer advice at this stage in relation to this particular issue.

As you may be aware, the RCAHMS has been undertaking survey work over the last twelve months or so at the Abbey.

We look forward to hearing from you.

Thank you for your letter.

The most relevant and most immediately available information that I can give you is from the Hutton Collection in the National Library of Scotland; these comprise a set of drawings and notes prepared for General Hutton by a local schoolteacher, James Shand, in 1815. I have acquired a respect for what Shand recorded at Dornoch, Tain, Fearn and Fortrose, and I think that you will find this small selection helpful. The wall marked x-x is particularly interesting, and I do think that the site of the proposed hall will impinge upon the area of at least some of the convent ual buildings and the burial-ground. I have also included a brief description of Fearn in <u>Firthlands</u> in <u>History</u>, which, I believe, has now been published.

I hope that this material will help to support your case for the time being. I should be able to give this matter rather more attention in early January when I may be able to come north to visit. Fearn and discuss the excursion intinerary for the Forestry conference.
