
ONE HUNDREDTH AMENDMENT OF COMBINED STATUTORY AND DESCRIPTIVE LIST OF BUILDINGS OF SPECIAL ARCHITECTURAL OR HISTORIC INTEREST FOR HIGHLAND COUNCIL: ALVIE PARISH; AULDEARN PARISH; LAGGAN PARISH

The Scottish Ministers in exercise of the powers conferred on them by section 1 of the Planning (Listed Buildings and Conservation Areas) (Scotland) Act 1997 and of all other powers enabling them in that behalf, having consulted those persons who appear to them appropriate as having special knowledge of and interest in buildings of special architectural or historic interest, hereby amend the COMBINED STATUTORY AND DESCRIPTIVE LIST OF BUILDINGS OF SPECIAL ARCHITECTURAL OR HISTORIC INTEREST for former Badenoch and Strathspey District and Nairn District issued on 18 August 1986 and 8 March 1985 respectively, to Highland Regional Council and amended on 2007 in the manner set out in the Schedule hereto.
